Status of work in CEN/TC 226/WG 3:

The revision work on the standard series EN 12899 is progressing rather slowly in some PTs (Project Teams). Drafting work is accomplished by 6 PTs dealing with the different parts of the standard series.

The convenor of WG 3 and WG 3 secretariat have set a tight schedule of meetings in order to provide guidance on the revision task and to keep a close follow-up of the work in the PTs. Moreover, WG 3 members were informed that first WDs were to be made available prior to the plenary in June 2015. During the WG 3 meeting in Copenhagen, WG 3 members agreed that the convenors of the PTs forward first WDs and meeting reports of past PT meetings, as well as to-do-lists with open points/issues still under revision, by 5th June 2015 for distribution in WG 3 Livelink.

The convenor and secretary have offered to do first editorials (template model standard for hEN, incorporation of approved A1 amendments in parts 1 and 3, etc.) on these drafts during the summer period prior to the next meeting of WG 3 scheduled for September 2015.

Regarding prEN 13422 rev, it turned out the first and second Round Robin Tests brought no reliable data and the Project Team therefore decided to launch a third Round Robin Test, which is on-going. One meeting took place in Autumn of 2014 since the last plenary meeting. Results of the 3rd Round Robin Test are expected by summer 2015 and will be discussed at a PT meeting in autumn 2015 respectively.

Questions to CEN/TC 226:

WG 3 is asking for general guidance in relation to the future use of classes and threshold levels in hEN for the revision process of EN 12899. Does CEN/TC 226 believe it to be preferable to omit the use of classes?
